Programs & Services



Residential

Children learn and grow best in a warm, nurturing and safe environment. At Spaulding, our cottages reflect typical home environments so that students are free to learn, explore and simply be children. Residential life addresses each child's needs by focusing on behavior, social and independent skills development. All residential students are assigned a dedicated team to help develop an individualized treatment plan and to ensure a consistent approach to the student's Individual Educational Plan (IEP) and clinical needs. After school programs, vocational opportunities and frequent evening and weekend excursions encourage children to develop and have fun in their larger community.



For over 10 years, Spaulding Youth Center has provided high-quality services to children, youth, and families as a licensed Child-Placing Agency. Our Individual Service Option (ISO) Foster Care program recruits, trains and licenses foster parents for children ranging in age from birth to 18. Our ISO In-Home Services provides support for our foster families and children, including developing a plan to transition the child toward permanency. We also provide Child Health Support services to foster parents, birth families and pre-adoptive homes to facilitate placement success.




