Located on a lofty hill in Northfield, New Hampshire, the 470-acre site offers a safe, caring and supportive environment to allow youth to heal, learn, grow, and play. Today, a staff of more than 180 professionals provides around-the-clock intensive residential treatment, educational and foster care services, for children and youth ages 5-20, with a range of challenges including autism, neurological impairments, behavioral difficulties, emotional difficulties and learning and developmental disabilities.

# We Celebrate Success Together


Dear Friends,



We took our seats as newly elected Chairs of our respective Boards last October, making fiscal year 2010 a pivotal year for the Board leadership of Spaulding Youth Center and Spaulding Youth Center Foundation. During these times of prolonged economic challenge and uncertainty, the support of children and youth education and social services are especially vulnerable and resources more limited than previously. We understand that our responsibilities and the decisions we make as Board leaders are ever more critical to boys and girls we help to learn, heal and grow, and to children in the future who will need Spaulding's programs and services.

At this year's joint Board Retreat, we put both our heads and our hearts into reflecting on the challenges and opportunities that lie ahead in fulfilling the mission of SYC. Under the guidance of our excellent Executive Team, our members left their familiar boardroom surroundings and spent time all over campus - talking with staff, meeting children, eating in the dining hall, visiting classrooms and residential cottages and seeing first hand the difficult, wonderful and transformative work that is being done at Spaulding by the children, their teachers, aides, therapists, nurses, counselors and families.

As a result of this experience and our continuing commitment to thoughtful change and growth at SYC, we appointed a Guiding Team of Board members and executive staff tasked with taking another hard look at the dream of building a new educational facility to assure that we continue to meet the needs of children and their families facing a range of challenges.

Our vision of a new school facility is only possible through the extraordinary efforts of staff, friends, parents, board members, the State of NH and other referral sources to maintain enrollment, recruit and retain top quality staff, and develop and implement highly regarded and effective programs and services.

We are deeply grateful to all for their loyal support and confident each of us will do what we can to help support the 'kids on the hill' now and for the future.

### Student Accomplishments and Program Highlights 2009-2010

In fiscal year 2010, the staff provided safe and nurturing residential treatment, educational and foster care services to 98 children and adolescents, ages 6 through 20, from 67 communities primarily across New Hampshire, but also from Connecticut, Maine, Massachusetts and Vermont.

An important measure of our success is gauged by tracking the number of our departing children who move to less restrictive settings. Eighteen of the 24 residential students who graduated or moved on during this year went to less restrictive settings such as their family or to a foster family. The outcome for our students in the Foster Care/ISO program, where enrollment continues to grow, was also very positive, with 8 of 9 day students leaving Spaulding for less restrictive settings.

Spaulding Youth Center's academic programs were evaluated this year by the New Hampshire Department of Education (DOE) Special Education Program Approval and Compliance Review process. A comprehensive visitation and case study resulted in our special education school receiving an outstanding report with

many commendations and a 5-Year DOE approval, the longest approval duration that is granted in this review process. The report affirmed the positive impact of all the ongoing hard work focused on continuously improving our services and



programs to achieve program excellence for the children and youth we educate.



# Highlights in the long list of commendations cited were:

• The one campus philosophy is well implemented – SYC operates as a collaborative educational community school comprised of many different learners who benefit from interaction, partnership and shared experiences with each other


 Classroom access to and use of interactive technology provides expanded learning opportunities

## Making a real difference in the lives of Spaulding's children.

We saw an expansion of our successful vocational program activities designed to help our older students transition into the community and learn important skills for independent living. SYC students are 'out and about' 4-5 days each week, working in the community as volunteers; learning to navigate the world of public transportation- interpreting schedules, riding buses, subways and touring airports; doing laundry in a coin operated laundromat; shopping for clothes and food; visiting businesses and learning




to be a part of a working team. This field experience is supplemented by classroom teaching in areas such as completing job applications, paying bills and reading and responding to help wanted ads. These experiences are transformative for many students who are engaged as learners and community members and are developing a growing interest and confidence in the larger world around them.

SYC student participation in Special Olympics games & events increased during the past year. Our athletes, the *Spaulding Shooting Stars*, embraced the opportunity to participate in bowling, snowshoeing at Waterville Valley,

track and field, soccer, and floor hockey. Our Special Olympians continue to be commended for their teamwork and good sportsmanship. The team rosters for our Special Olympics athletes totaled 76 students. SYC staff participated along side the students in supporting and cheering their efforts. In mid-winter, some very brave members of our staff and Board took the 'Penguin Plunge' in the frigid Atlantic Ocean to help raise additional funds for the Special Olympics program.
